- **Principal Contractor Member (annual fee \$800)**

Principal Contractors must be of good standing, personally contracting directly with clients as being responsible for the full construction of tennis or sports courts, sports fields or recreational areas, have been so occupied in their main business activities for the two years preceding the date of application for membership and must have constructed these projects to standards and value acceptable to the Board, and continue to be so occupied in their business activity during the term of membership. New members are designated 'provisional contractor' members in their first twelve months of membership of SAPIA. New companies that have not been in existence for two years are designated 'provisional contractor' members for their first two years of membership of the SAPIA.

- **Surfacing Contractor Member (annual fee \$500)**

Surfacing Contractors are not operating as principal contractors in their own right, but are sub-contractors specialising in surfacing only services to members or other sports and recreation contractors, operating in one State only.

- **Associate Contractors (annual fee \$500)**

Applicants are suppliers of associated goods and services, e.g. fencing installers, earthworks contractors, concreters and block layers, maintenance personnel, to the sports and recreation contracting industry, operating in one State only.

- **Professional Services Member (annual fee \$500 one State / \$800 more than one State)**

Applicants are suppliers of professional services, e.g. professional consultants, engineers, architects and testing labs involved with the sports, play and recreation industry.

- **Manufacturer and Supplier Member (annual fee \$800)**

Applicants are manufacturers and/or suppliers of products related to the sports, playground and recreation industry, including but not limited to sports and play equipment, synthetic turf, acrylic surfacing, fencing materials, quarry materials and sports lighting.

- **Affiliate Member**

Sports governing bodies, reciprocal peak bodies, fund-raisers and honorary members involved with the sports and recreation contracting industry.

Principal and Surfacing Contractors should also provide copies of the following documents, if applicable:

- Builders or Trade Licence/s held (appropriate for States worked in) or other accreditation;
- Current \$20M product and public liability insurance policy Certificate of Currency (in the case of playground contractors, this should be endorsed for playground softfall design and installation);
- Current WH&S Policy;
- Current Workcover Policy;
- Warranty Statement and Care & Use Documentation;
- Playground Contractors Only: Current certified system impact certificates in company or individual's name.
